# 4. Public Participation

Representations were made in respect of the ongoing parking issues on the highway on Drayton High Road (cul de sac numbers 21 to 41). Advice had been sought concerning the introduction of permit parking and the Clerk advised he would email the resident with further details.

#### 5. Reports

#### **County Councillor**

Cllr Adams provided a verbal report.

- Discussion with all the relevant authorities were on going in relation to the Royal Norwich Golf Course development.
- Details had been issued concerning drainage schemes on the Low Road and School Road due to start in February 2016. It was hoped thee schemes once completed would reduce flooding issues in the area.
- Consultation was ongoing concerning the Norfolk Fire & Rescue Service proposals. There was only one proposal that affected Drayton which involved the reduction of fire provision at North Earlham which provides cover for the Drayton area.

A discussion took place following the information from Cllr Adams concerning the Fire Service proposals. **RESOLVED** to inform Norfolk County Council that the Parish Council objects to the proposal to reduce fire provision at North Earlham and would advise that:

- Drayton has 2500 properties most in a high density
- Drayton is due to have an additional 200 homes built within the next 18 months.
- The airport flight path is directly over Drayton
- Drayton is close to a major chemical works near to the border of Hellesdon / Drayton
- If a major incident occurred elsewhere during the 500 hour period when there is no fire cover at North Earlham this would necessitate a fire tender having to possibly attend from as far afield as Aylsham which is approximately 10 miles away.
- In the consultation document it is accepted the anticipated savings depend on continuing to receive a grant from the DCLG for the USAR and if this grant is phased out there will eventually be no savings at all.
