Norwich Airport Consultative Committee

Cllr Wilkinson attended the meeting held earlier today at Hellesdon Parish Council's offices. A couple of issues were raised of immediate interest to Drayton.

- The policy concerning the flying of drones had changed since the recent events at Gatwick and Heathrow.
- Operators were increasingly trying to put pressure on to the airport to try and extend flying times. The current ban on flights between 11pm and 6am had been as a result of a public enquiry. Opposition to an extension would be met with fierce opposition from local parish councils.
